Eccles called the meeting to order at 7:00 p.m. Public communications: There was a request for a child swing at the park. SAEG is working on this. There was also a request for updates at the park.

Maintenance report was given by Jim Thurman. It was decided the Town will start using the chemical LPC-AM for treating the water. Price is \$26 per gallon with proposed usage of 1 gallon per day. This chemical is recommended to reduce the disadvantages of using hard water.
